

Section 1 - Aviation Premises Liability

- \$6,000,000 Each Occurrence Premises Liability to include premises incidental to the aviation operations of the Insured
Deductible: \$1,000 Each Occurrence for Property Damage
- \$1,000,000 Each Occurrence/ Aggregate Products and Completed Operations
- \$1,000,000 Per Occurrence and \$6,000,000 Aggregate for Food, Beverage and Host Liquor Liability
- \$1,000,000 Any one premises with respect to Tenant's Legal Liability

Section 2 – Air Meet Liability

Sums which the Insured shall become legally liable to pay, and shall pay, as compensatory damages in respect of accidental Bodily Injury and accidental Property Damage arising out of the organization of, involvement in and sponsorship of:

- (a) Air Meets, fly-Ins, poker derbies, fly-outs, non-racing rallies, formation flying demonstrations and other similar events;
- (b) 'Rust remover' safety seminars and fly-ins and other aviation related seminars and fly-ins, including formation flying seminars;
- (c) '**Discover Aviation**' events run by COPA Flights;
- (d) 'COPA Conventions' organized by a COPA Flight or any other party;
- (e) Airshows/Air Demonstrations (conditions apply)

Limit of Coverage:

- \$6,000,000 Each Accident and in the annual aggregate each Policy Year
- \$1,000,000 Each Accident and annual aggregate for Food, Beverage and Host Liquor Liability
- \$1,000,000 Each Accident as respects to Tenants Legal Liability
- Deductible Nil

Section 3 – Non-Owned Aircraft Liability

Sums which the Insured shall become legally liable to pay, and shall pay, as compensatory damages in respect of accidental Bodily Injury and accidental Property Damage arising out of:

- (a) The operation of any aircraft, including in connection with “**Discover Aviation**” events;
- (b) The use of any aircraft by COPA

Limit of Coverage:

\$6,000,000	Each Accident Combined Single Limit Bodily Injury and Property Damage
\$250,000	Each Accident for Liability for Physical Damage to Non-Owned Aircraft used by Canadian Owners and Pilots Association
\$2,500,000	Each Accident as with respect to liability of pilots operating Canadian registered aircraft during “ Discover Aviation ” events. Such coverage is to apply in excess of the underlying limit carried by the pilot/owner of the aircraft which must include a minimum limit in respect of passenger legal liability of \$100,000 per passenger or the Transport Canada minimum standards per CARS 606.02.
\$1,000	Property Damage Deductible, each Accident
